

**RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK,  
AND INDEMNITY AND PARENTAL CONSENT AGREEMENT  
("AGREEMENT")**

In consideration of being permitted to participate in any way in on-ice and/or hockey event activities during the 2017-18 AHL hockey season ("Activity") I, for myself, my personal representatives, assigns, heirs, and next of kin:

1. ACKNOWLEDGE, agree, and represent that I understand the nature of the Activity and that I am qualified, in good health, and in proper physical condition to participate in such Activity. I further agree and warrant that if at any time I believe conditions to be unsafe, I will immediately discontinue further participation in the Activity.

2. FULLY UNDERSTAND THAT: (a) the Activity INVOLVES RISKS AND DANGERS OF SERIOUS BODILY INJURY, INCLUDING PERMANENT DISABILITY, PARALYSIS, AND DEATH ("RISKS"); (b) these RISKS and dangers may be caused by my own actions or inactions or the actions or inactions of others participating in, supervising, aiding in, or otherwise taking part in the Activity, the condition in which the Activity takes place, or the negligence of the RELEASEES named below; (c) there may be OTHER RISKS AND SOCIAL AND ECONOMIC LOSSES either not known to me or not readily foreseeable at this time; and I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS, AND DAMAGES INCLUDING, BUT NOT LIMITED TO, ATTORNEYS' FEES AND COSTS, I incur as a result of my participation or that of the minor in the Activity.

3. HEREBY RELEASE, DISCHARGE, AND COVENANT NOT TO SUE Stockton Heat ("AHL Team"), its respective owners, administrators, directors, agents, officers, members, volunteers, and employees, AHL Inc., AHL Properties, LLC, other participants, any sponsors, advertisers, and, if applicable, owners and lessees of premises on which Activity takes place, (each considered one of the "RELEASEES" herein) FROM ALL LIABILITY, CLAIMS, DEMANDS, LOSSES, OR DAMAGES INCLUDING, BUT NOT LIMITED TO, ATTORNEYS' FEES AND COSTS, ON MY ACCOUNT CAUSED OR ALLEGED TO BE CAUSED IN WHOLE OR IN PART BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, INCLUDING NEGLIGENT RESCUE OPERATIONS; AND I FURTHER AGREE that if, despite this RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT, I or anyone on my behalf, makes a claim against any of the RELEASEES, I will indemnify, save and hold harmless each of the RELEASEES from any litigation expenses, attorneys' fees, loss, liability, damage, or cost which any of the RELEASEES may incur as the result of such claim.

**I HAVE READ THIS AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT AND HAVE SIGNED IT FREELY AND WITHOUT ANY INDUCEMENT OR ASSURANCE OF ANY NATURE AND INTEND IT TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW AND AGREE THAT IF ANY PORTION OF THIS AGREEMENT IS HELD TO BE INVALID, THE BALANCE, NOTWITHSTANDING, SHALL CONTINUE IN FULL FORCE AND EFFECT.**

## Boy Scout Night Itinerary

Note: If you are not in the correct location at the proper time, you risk forfeiting the experience. Also, all waivers must be signed ahead of taking part in any experience.

1. 4:00 P.M.: VIP Tour attendees enter the arena through the south entrance, located closer to the Banner Island Ballpark's Left Field Foul Pole. Gather in south lobby.
2. 4:15 P.M.: Begin VIP Pre-Game Tour of the arena.
3. 5:00 P.M.: End VIP Pre-Game Tour of the arena.
4. 5:00 - 5:15 P.M.: Show location of where scouts will need to be for their assigned roles, as well as explain the timing of and direction on how to properly perform assigned roles for the pre-game ceremonies.
5. 5:15 – 5:30 P.M.: Scouts that will be watching the Warm-Ups from the Bench or Penalty box will be brought out to the Bench/Box no later than 5:15 P.M. For other scouts, this time will be used as a brief break to visit seats, bathroom, pack/troop or concessions.
6. 5:30: All scouts and necessary leaders/parents return to assigned locations. For scouts that are holding the flag, but were not on the tour, they must wait in front of the Fan Attic Team Store at this point.
7. 5:30 – 6:00 P.M.: Be prepared for pre-game assignments, including holding the giant American Flag, color guard (PACK 451) & ceremonial puck drop, ask any final questions, and then perform the pre-game ceremonies.

8. 6:00 P.M.: All scouts are dismissed from pre-game ceremony requirements. Free to enjoy the rest of the game.

Any additional in game experiences must be in the proper locations at the correct time, or else they may forfeit their experiences. This includes the first intermission Zamboni rider being at Bruce's Body Shop Sales & Service information desk with 8 Minutes left in the first period.

### **Pre-Game Ceremony Locations:**

**Ceremonial Puck Dropper** – Should be coming from the Team Bench and will wait back of house behind Zamboni tunnel until pre-game ceremonies begin. Once the ceremony begins he will be in the Zamboni tunnel, and will be prompted after the Anthem to step out onto a carpet to drop the puck.

**Giant Flag Holders:** Those who come from the team bench will be brought back of house behind the Zamboni tunnel where the flag will be. Those who had a break, or were not part of the tour will gather outside of the Fan Attic Team Store by the south entrance at 5:30.

**Pack 451 Color Guard:** Those who are coming from the team bench will gather back of house behind the Zamboni tunnel. Those who took a break, or were not part of the tour will gather in front of Team Store at 5:30 with additional scouts/leaders. Note: Flags can be brought in at the time of the tour, or through the south entrance any time 4:30 or forward, just say you are with the color guard and get your tickets scanned.

### **Pre-Game Ceremony Timing:**

At about 5:53 the lights will go off in the arena for a promo video. During this time the flag holders will shuffle out along the right side of the boards in relative darkness, until

about 5 feet short of the blue line. It is important to stay along the board this entire time. The team will come out of the tunnel at the conclusion of the video, as this happens please be aware that the fans on the other side of the glass will be shaking the glass quite a bit. Do not unroll the flag until the players have stopped skating. As soon as they do you will be instructed to unroll the flag as you rotate and move out over the center part of the zone between the blue line and the goal. The stars should be towards the goal, while the stripes towards the blue line. It is imperative that we do this in a quick manner as to not disrupt the timing of the color guard or Anthem.

Once the giant flag has been situated the P.A. Announcer will recognize the Pack 451 Color Guard, which will have been waiting at attention in the Zamboni Tunnel. They will begin marching out onto the mats that will be positioned on the ice. Note, there is netting at about 8 feet, so flags will need to be dipped under this to make it out onto the ice. One uniformed den/pack master will need to be there for supervision.

Once the color guard has halted, the P.A. Announcer may recognize a hero of the game if there is one selected for the game. If there is it will go to a quick P.A. read about the Hero and then the anthem, if no hero is selected for the game then the P.A. Announcer will immediately recognize the National Anthem Choir from Blaker Kinser Junior High.

Immediately following the conclusion of the National Anthem the Giant Flag Holder must begin rolling the flag and moving off the ice simultaneously. This needs to be a very quick process, as the flag will be the last thing keeping the game from starting. It is imperative that the giant flag be ready to come off the ice as soon as the ceremonial puck drop is concluded.

At the same time, following the Anthem, the Color Guard must clear, and the Ceremonial Puck Dropper will come out on the mats, and wait for a player from both teams to meet in front of them. The Puck Dropper will wait a moment for a picture, and then drop the puck. The players will shake hands with the Puck Dropper, give the Puck back, and then the Puck Dropper needs to clear the mats.

As soon as the puck dropper has cleared, the flag holders need to get off the ice. Remember this is the final thing keeping the game from getting started.

Please remember that all of this happens in about a 5-6 minute span, so it is very quick. Memorize your assignments and your different cues. If the BSA is to look good, we can't let there be any mishaps.
